Justice Prince CIC hold a 40 year lease on 0.18 hectares of allotment land located in the heart of Longbenton.

We have recently transformed the community garden with a capital grant through the UKSP, works included felling dangerous dead trees, installing a new polytunnel, pathway, raised beds and connecting our solar energy to the northern power grid which means we can use our modular all year round. The capital works has increased our capacity to work with those who have a physical disability.

We want to continue to improve our offer on the community garden. Maintenance is always a challenge as we don't have enough equipment to effectively manage the site. We would like to purchase capital items which include two strimmer's, one grass cutter, one long reach head trimmer, 2 wheel barrows, 4 spades, 4 shovels, 4 rakes and 8 water soakers to enable us to water our fruit orchard. We would also like to purchase 10 water butts.

We would also like to build new potting benches around the newly installed polytunnel to ensure children and those who are disabled can access the benches with ease. Our current benches are old and too high for children and those in wheel chairs.

We would also like to increase the raised beds to extend along the newly installed pathway, this will be our "sensory walk" we will plant a range of flowers, shrubs and herbs that will attract bees, butterflies and other wildlife to the garden. This will increase our bio-diversity on site.

Residents living on Longbenton estate will be the beneficiaries, those suffering greatest socio-economic health inequalities who are typically in poor health and furthest away from the labour market.

The community garden offers a safe place to visit and enjoy a range of activities from simply meeting other people in a social capacity to planting seeds to other gardening activities such as supporting the overall maintenance of the garden.

We work with [REDACTED] offering children weekly sessions, the children will massively benefit from our new improved offer on site, we will engage the school in planting our sensory walk along the newly installed path making access and egress far safer than before.

Because there is a range of activities including arts and crafts on site, we will engage a large cross sector of the community and hoping to increase our ethnic diversity as a result UKSP funding.

We will increase our offer to local people living in Longbenton, particularly those suffering greatest financial hardship and those suffering poor physical and mental health. We will also be able to improve our training and development on site, in particular, working with the award winning Working Roots programme. We currently provide training to [REDACTED] who would really benefit from using new equipment and being part of the development on site.

Residents will enjoy a safe, inclusive stimulating environment where local people can thrive instead of people merely surviving the daily grind. New friendships will emerge, as trust builds, new and exciting initiatives will be developed on site, such as community cooking using produce grown and harvested on site. This longer term will improve peoples knowledge of healthy eating, reduce their food budget and of course, will increase daily physical exercise.
