PUBLIC FOOTPATHS CROFTWOOD 1, 2, 3, 4, 5 & 6

This Order is made by North Tyneside Council ("the Authority") under Section 53(3)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the authority that the Definitive Map and Statement requires modification because in accordance with the provisions of Section 53(3)(c)(i) the Council has discovered evidence which when considered with all other relevant evidence available to them raises a reasonable presumption that the Public Footpaths have been dedicated as public rights of way.

BY THIS ORDER:

1. For the purpose of this Order the relevant date is 24 April 2026
2. The Definitive Map and Statement be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Killingworth - 'Croftwood' 1, 2, 3, 4, 5 & 6 Definitive Map & Statement Modification Order 2026.

SCHEDULE
PART 1
DESCRIPTION OF PATH OR WAY

Public Footpath – Croftwood 1:

There shall be added to the Definitive Map a public footpath shown by a bold continuous black line marked on the map attached to this Order commencing at its north end and its junction with an already recorded public footpath approximately 48 metres south of West Lane, Killingworth Village at:

Grid Ref: NZ 428178 / 570875 **(Point A)**

the path proceeds east into 'Croftwood' before turning largely south where it crosses Croftwood 2 and continues largely south to its end point at its junction with Croftwood 4.

Grid Ref: NZ 428213 / 570694 **(Point B)**

Comprising a total distance of approximately 225 metres.
Width - 1 metre.

Public Footpath – Croftwood 2:

There shall be added to the Definitive Map a public footpath shown by a bold continuous black line marked on the map attached to this Order approximately 129 metres south of West Lane, Killingworth Village at its junction with an already recorded public footpath to the external northeast corner of St Joseph's Field, Killingworth at:

Grid Ref: NZ 428165 / 570795 **(Point C)**

the path proceeds east into 'Croftwood' crossing over Croftwood 1 before turning largely south to its end point at its junction with Croftwood 4 at:

Grid Ref: NZ 428232 / 570692 **(Point D)**

Comprising a total distance of approximately 164 metres.
Width - 1 metre.

Public Footpath – Croftwood 3:

There shall be added to the Definitive Map a public footpath shown by a bold continuous black line marked on the map attached to this Order commencing at its north end within Croftwood at its junction with Croftwood 2 at:

Grid Ref: NZ 428190 / 570793 **(Point E)**

the path heads largely south where it crosses Croftwood 4 and continues largely south through to its end point at its junction with Croftwood 5 at:

Grid Ref: NZ 428192 / 570595 **(Point F)**

Comprising a total distance of approximately 204 metres.
Width - 1 metre.

Public Footpath – Croftwood 4:

There shall be added to the Definitive Map a public footpath shown by a bold continuous black line marked on the map attached to this Order commencing at its north end at its junction with an already recorded public footpath to the external midpoint of St Joseph's Field, Killingworth at:

Grid Ref: NZ 428149 / 570700 **(Point G)**

the path heads east into Croftwood where it crosses Croftwood 3 and continues largely south through to its end point at its junction with Croftwood 5 at:

Grid Ref: NZ 428277 / 570577 **(Point H)**

Comprising a total distance of approximately 234 metres.
Width - 1 metre.

Public Footpath – Croftwood 5:

There shall be added to the Definitive Map a public footpath shown by a bold continuous black line marked on the map attached to this Order commencing at its west end at its junction with an already recorded public footpath to the external east side of Denewood, Killingworth at:

Grid Ref: NZ 428134 / 570605 **(Point I)**

the path heads east into Croftwood where it intersects with the south ends of paths Croftwood 3 and 4 – it then turns southeast through to its end point at its junction with the footway on the west side of Killingworth Road, Forest Hall at:

Grid Ref: NZ 428333 / 570522 **(Point J)**

Comprising a total distance of approximately 226 metres.
Width – 1 metre.

Public Footpath – Croftwood 6:

There shall be added to the Definitive Map a public footpath shown by a bold continuous black line marked on the map attached to this Order commencing at its west end at its junction with an already recorded public footpath to the external east side of Denewood, Killingworth at:

Grid Ref: NZ 428137 / 570591 **(Point K)**

the path heads largely east northeast into Croftwood through to its end point at its junction with Croftwood 5 at:

Grid Ref: NZ 428157 / 570597 **(Point L)**

Comprising a total distance of approximately 27 metres.
Width – 1 metre.

PART 2
DEFINITIVE STATEMENT

Public Footpath – Croftwood 1:

Commencing at its north end and its junction with a public footpath approximately 48 metres south of West Lane, Killingworth Village – the path proceeds east into Croftwood before turning largely south crossing another public footpath and continuing south through to its end point at its junction with another public footpath approximately 33 metres west of external southwest corner of the ‘Old Stables’ land parcel off Killingworth Road, Killingworth.

Comprising a total distance of approximately 225 metres.

Width - 1 metre.

Public Footpath – Croftwood 2:

Commencing at its north end and its junction with a public footpath approximately 129 metres south of West Lane, Killingworth Village, to the external northeast corner of St Joseph’s Field, Killingworth – the path proceeds east into Croftwood crossing another public footpath before turning south through to its end point at its junction with another public footpath approximately 11 metres west of external southwest corner of the ‘Old Stables’ land parcel off Killingworth Road, Killingworth.

Comprising a total distance of approximately 164 metres.

Width - 1 metre.

Public Footpath – Croftwood 3:

Commencing at its north end within Croftwood at its junction with another public footpath and approximately 26 metres east of the northeast corner of St Joseph’s Field, Killingworth – the path heads largely south crossing a public footpath through to its end point at its junction with another public footpath approximately 60 metres east of the external east side of Denewood, Killingworth.

Comprising a total distance of approximately 204 metres.

Width - 1 metre.

Public Footpath – Croftwood 4:

Commencing at its north end at its junction with another public footpath to the east of the midpoint of the St Joseph's Field, Killingworth – the path heads east into Croftwood crossing a public footpath to the external south end of the 'Old Stables' land parcel off Killingworth Road, Killingworth before turning largely south through to its end point at its junction with another public footpath approximately 80 metres northwest of Killingworth Road, Killingworth.

Comprising a total distance of approximately 234 metres.

Width – 1 metre.

Public Footpath – Croftwood 5:

Commencing at its west end at its junction with a public footpath to the external east side of Denewood, Killingworth – the path continues east into Croftwood where it intersects with the south ends of two other public footpaths before turning southeast through to its end point at its junction with Killingworth Road, Killingworth.

Comprising a total distance of approximately 226 metres.

Width – 1 metre.

Public Footpath – Croftwood 6:

Commencing at its west end at its junction with a public footpath to the external east side of Denewood, Killingworth – the path continues east northeast into Croftwood through to its end point at its junction with another public footpath.

Comprising a total distance of approximately 27 metres.

Width – 1 metre.
